

# Ground Cover Approval Application

(OUTSIDE SPACES ONLY)

Exhibitors may choose to rent bark directly from World Ag Expo® or may provide approved ground cover for outdoor spaces. Exhibitor must adhere to all fire and safety codes.

- If you rent bark from World Ag Expo® you do **NOT** need to complete this form. [Bark Order Form](#)
- Ground cover must be placed and removed by the exhibitor or approved contractor.
- Grounds must be returned to their original state.
- Removal must be completed no later than February 23, 2024.
- Ground cover may **NOT** be disposed of in World Ag Expo® trash receptacles.
- No World Ag Expo® equipment or labor will be used in placement or removal of ground cover.
- Any ground cover left after February 23, 2024, becomes property of World Ag Expo® and will result in forfeiture of deposit.
- Exhibitor must pay the refundable ground cover deposit of \$500.00.
- **Exhibitor must have approval from WAE, and deposit be paid in full before placing ground cover.**
- Deposits will be refunded based on the level of clean-up necessary (by WAE) to return the grounds to their original state; additional charges may be added for excessive clean-up or repair.
