This form should be used to request security for a special need or overnight security in an Exhibitor's space.

Alcohol is allowed inside Exhibit Space with approval from World Ag Expo® management for small gatherings only. Security is required. Exhibit Space is not intended for events or large gatherings. For large gatherings or parties, please contact our Facilities Rentals Team.

Exhibitors or groups must abide by California Alcohol Beverage Control (ABC) rules if serving alcohol in rented event space as defined by Code Section 23399.1 of the Alcoholic Beverage Control Act:

1. World Ag Expo Management must be notified prior to the show of intent to serve alcoholic beverages.

2. Alcohol must be served at NO charge, not sold.

3. An ABC licensed server must obtain a Liquor License and pour the alcohol in the space.

Please call the office at (800) 999-9186 ext. 2018 for exceptions or questions.

4. Service and consumption must be within a defined area (with the rented event space) and be secured with a minimum of two security guards in order to check attendee I.D.'s and ensure no alcohol leaves the defined area.

- Allowing guests or activities associated with your gathering to spill into common areas such as streets or neighboring booth spaces.
- Any behavior that, in Show Management's discretion, creates a disturbance or negatively impacts the event experience.

Show Management reserves the right, at its sole discretion, to require the gathering to be modified, reduced, or discontinued, including shutting down alcohol service or the gathering entirely, if it becomes disruptive or interferes with other exhibitors, attendees, or the overall event.
